The prices of such equipment shall be refunded by the vendor with 18% interest if such payments for such equipment has already been made to him.
- 1. All damaged or unapproved goods shall be returned at suppliers cost and risk and the incidental expenses incurred there on shall be recovered from the supplier. Defective part in equipment, during warranty period, shall be replaced within 30 days on receipt of the intimation from the TEQIP office at the cost and risk of supplier including all other charges.

In case of any loss/damage to equipment and supplies during the transportation from the origin of equipment to the delivery site, the supplier has to replace it with new equipment/supplies immediately at his own risk.
