4. Terms and Conditions

- a. The contract shall be for the full quantity as described above.
- b. Corrections, if any, in specifications for matter offered and rates & terms and conditions shall be made by crossing out, initialing, dating and re-writing.
- c. All duties and other levies payable by the supplier under the contract shall be included in the unit price.
- d. Applicable taxes shall be quoted separately for all items.
- e. The prices quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- f. The Prices should be quoted in Indian Rupees only.
- g. Each bidder shall submit only one quotation.

The prices of such equipment shall be refunded by the vendor with 18% interest if such payments for such equipment has already been made to him.
- m. All damaged or unapproved goods shall be returned at suppliers cost and risk and the incidental expenses incurred thereon shall be recovered from the supplier. Defective part in equipment, if found before installation and/or during warranty period, shall be

replaced within 45 days on receipt of the intimation from the TEQIP office at the cost and risk of supplier including all other charges.

- n. In case of any loss/damage to equipment and supplies during the transportation from the origin of equipment to the installation site, the supplier has to replace it with new equipment/supplies immediately at his own risk.
